Project Purpose: This project will focus on serving 500 individuals seeking employment and training in childcare occupations and create 500 additional childcare slots for Wisconsin's workers. It seeks to address known deficiencies in the childcare economy related to access, quality, affordability, and wages through the provision of employment and training services, supportive services, business engagement, microenterprise and entrepreneurial skills development, and the creation of disaster-recovery employment.
