Schramm directed members to the sheet that says "detail of negotiations." She stated that we took all the data that the state gave us and compared it. They are using a regression formula that adjusts performance based on how barriered the population is. Schramm stated that what they are proposing in many areas, we are achieving already.

Youth Median Earnings – No data available. Set a baseline.

Youth Credential – 82.6%, recommending 66%.

Youth Measureable Skill Gain – Establishing baseline data. 49.8%. Will go up with pre-apprenticeship programming.

MOTION: Christenson asked for a motion to approve the recommendation to be sent to the Department of Workforce Development as discussed. Pulford moved to approve and Cataldo offered the second. No discussion followed on this motion. The vote was unanimous in favor of the motion.

Christenson asked if it benefits us to shoot for anything higher. Schramm stated that we will get rewarded if we go over anything they set. We do believe incentive awards will come into play in 2022 when all standards are place. Every time we reach a goal, they automatically set the goal higher for the next year.

Clarke stated that the committee will need a briefing on how they arrive at these goals. We will have Brian, the DWD data staff, to come do a presentation.

Schramm shared that we had an excellent review by DOL for monitoring last week. They were very pleased with our work and it was a great experience for staff.
